LIABILITY WAIVER AND RELEASE AGREEMENT:

I acknowledge and understand that by signing this Liability Waiver and Release Agreement, I am waiving certain legal rights, including the right to initiate legal action against the event organizers, sponsors, and other associated parties.

I am fully aware that snowmobile racing events involve not only the usual dangers and risks inherent in the sport of snowmobiling but also additional hazards, including but not limited to, the risk of collision with natural and man-made objects, other snowmobiles, and spectators. These risks are significant and may result in serious personal injury, permanent paralysis, and/or death. Despite this, I knowingly and freely accept and assume all such dangers and risks, whether known or unknown, as well as the potential for personal injury, death, property damage, or loss arising from my participation in this event.

IN CONSIDERATION OF MY PARTICIPATION IN THIS EVENT, I HEREBY AGREE AS FOLLOWS:

- **WAIVER OF CLAIMS:** I waive any and all claims that I may have against the race organizers, sponsors, venue operators, event staff, volunteers, and their respective directors, officers, employees, agents, and representatives (hereinafter referred to as the "Releasees").
- **RELEASE OF LIABILITY:** I release the Releasees from any and all liability for any loss, damage, injury, or expense that I may suffer, or that my next of kin may suffer, as a result of my participation in the event, due to any cause whatsoever, including but not limited to negligence on the part of the Releasees.
- **HOLD HARMLESS AND INDEMNITY:** I agree to hold harmless and indemnify the Releasees from any and all liability for property damage or personal injury to any third party resulting from my participation in the event, whether caused by negligence on the part of the Releasees or otherwise.
- **BINDING EFFECT:** I acknowledge that this Release of Liability shall be effective and binding upon my heirs, next of kin, executors, administrators, and assigns in the event of my injury or death.

I confirm that I am at least 18 years of age, have read and fully understand this Liability Waiver and Release Agreement, and acknowledge that by signing this document, I am voluntarily waiving certain legal rights that I, my heirs, next of kin, executors, administrators, & assigns may have against the releases.
